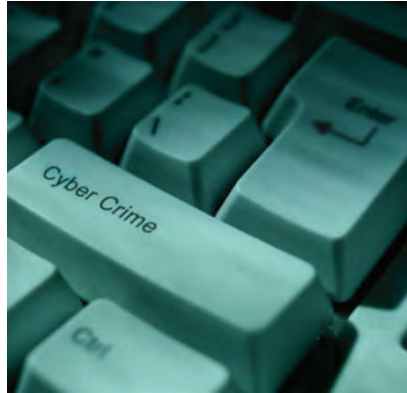
The mission of the USCC:

This camp features one week of specialized cybersecurity training that includes workshops, a job fair, and a culminating “Capture the Flag” competition. The workshops are led by college faculty, top SANS Institute instructors, and cybersecurity experts from the community. The workshops and presentations focus on a variety of topics ranging from intrusion detection, penetration testing and forensics.

Participants can also participate in a job fair that provides them the opportunity to meet with USCC sponsors and discuss potential employment. The weeklong program ends with a competitive “Capture the Flag” competition and an awards ceremony attended by notables in the cybersecurity industry and government.

Participants of the camp competed in the qualifying Cyber Quests online competition in April 2014 to earn a spot at a USCC Summer Cyber Camp. Camp spaces are limited, competitive and by invitation only, so the elite group of attendees have tested their cyber skills and advanced into their next journey toward being a “cybersecurity defender”.
